## **Capitol Advisors (CAG)**

**The Governor's proposed budget** includes \$106.3 million in additional ongoing Proposition 98 General Fund resources to fully fund universal school meals program for SY 2025-26.

**New KIT Funding** includes \$150M for kitchen equipment, infrastructure, and training to support the preparation of freshly made meals using locally sourced ingredients.

Executive Order by Governor Newsom addresses the impact of "ultra-processed foods" and aims to further improve school nutrition standards where possible given logistics, costs, and other factors. The order directs the State Board and CDE to explore ways to exceed federal meal standards by October 2025, while the CDFA will work on forging new partnerships to strengthen school food programs. Although the unknown can cause some trepidation, the order's practical focus is promising, and we'll continue collaborating with the Governor's Office, CDE and other involved parties to ensure our input is heard. Updates will be shared at upcoming LAC meetings.

## CDE Update

**Town Hall:** Mark your calendars! The first Town Hall of the new year will take place on January 28.

USDA Local Foods Funding: The USDA has announced another round of Local Foods for Schools and Child Care (LFSCC) funding, aimed at promoting procurement from small, disadvantaged farmers. This cycle includes \$50 million for schools, with the remainder allocated to childcare programs. The first round of funding is expected in July.

**Language Access:** Brochures are in the process of being translated in the five threshold languages.

**Satisfaction Survey:** Survey questions and procedures are being finalized for the satisfaction survey, launching in January, to identify future needs and ensure continued support.

**Partner Mapping:** Efforts are underway to collect baseline data on meal recipients, program operators, and external partners to identify areas for improvement and promote equity for California's served and underserved populations.
